[A] - 3/4" (19 mm) MDF



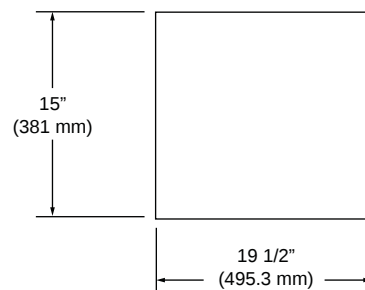
[C] - 3/4" (19 mm) MDF



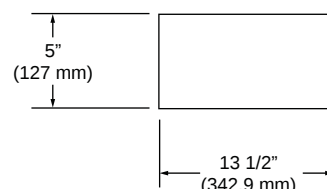
